<p style="text-align: center;">If the product is made up of several components then a raw material extraction location needs to be provided for each component. "Extraction" refers to the location of where the material originates from. For example, if 50% of the aluminum for a window frame is mined in Buffalo, NY, and the other 50% is recycled content that is collected from the area surrounding the window frame manufacturing facility which is located in Toledo, OH then both extraction sites need to be submitted.</p>

<p style="text-align: center;">"Post consumer" refers to material generated by households or by commercial, industrial, and institutional facilities in their role as end-user of the product, which can no longer be used for its intended purpose. An example of this would be pop cans that are recycled to make an aluminum window frame.</p>			
Pre-Consumer recycled content (%)	0		
<p style="text-align: center;">"Pre consumer" refers to material diverted from the waste stream during the manufacturing process. An example of this would be aluminum shavings that are generated in the manufacturing of aluminum window frames that are reclaimed and put back into the window frame manufacturing process.</p>
